Specification for FRP pools

- 1 Should be made with food and UV resistant grade material with Isophthalic Unsaturated polyester.
- 2 Wall Thickness of 5.0 mm
- 3 Inside finishing with Gelcoat finish
- 4 Lamination: Resin Laminates to contain a minimum glass content of 40% using Fibre glass Matrix of 450 GSM Density
- 5 Laminate should have a specific gravity of 1.65 and exhibit a minimum tensile strength of 3700NN/Sq mtr. As per IS 1998
- 6 Barcol hardness should be of 45 as per ASTM 2583-81
- 7 Water absorption of not more than 0.20 as per ASTM D 570
- 8 Pools should be anti-algae
- 9 Operating temperature resistant up to 90°C
- 10 With provision of inlet and outlet drains

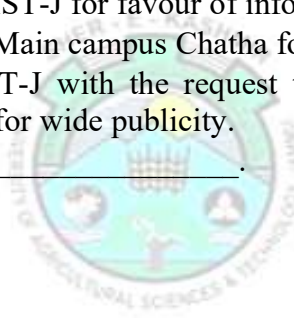
