Agriculture programme, the following waitlisted candidates issued vide notification no: 128 (Acad.) of 2021 dated 26-11-2021, No. 31 (Acad.) of 2022 dated 02/02/2022 & vide notification No: 13 (Acad.) of 2022 dated 17/01/2022 and hereby informed to deposit the prescribed fee mentioned against each category (refer details at "A" & "B" below) through online or offline mode in favour of the following A/c holders (stream wise) of J&K Bank **on or before 15th March 2022** failing which the invitation extended to them shall be treated as cancelled and such invitees shall have no claim on the seat.

The candidates thereafter shall have to report to the concerned Dean of the Faculty for registration in the 1st year /1st semester of the academic session 2021-22.

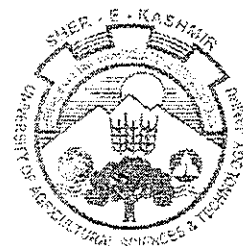
