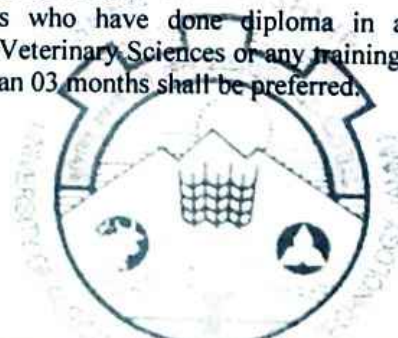
Sub: Hiring of Veterinarians and Paravets on temporary basis.

Terms and conditions:

1. The candidates shall be hired for a period of 01 (one) year extendable to a maximum period of 02 (two) years.
2. The candidates shall be paid as per the rates approved by Department of Animal Husbandry and Dairying, GOI, and the indicative stipend is Rs. 50,000/- per month for Veterinarians and Rs. 20,000/- per month for Paravets.
3. The job is of temporary nature, and the candidates should provide an affidavit attested by a 1st Class Magistrate stating that he/she is applying for a temporary job and has no claim over the post applied for and his/her services can be terminated any time with a prior notice period of one month.
4. The services of the candidates shall be utilized strictly as per the guidelines of the Establishment and Strengthening of existing Veterinary Hospitals and Dispensaries-Mobile Veterinary Unit scheme.
5. Candidates must apply for his/her domicile district only, and selection shall be made at district level.
6. Candidates shall pay fee of ₹ 500/- (Five hundred only) through online mode.
