## Norms for Testing of Various Agro-products

### 1. Testing procedures of hybrids/varieties

Testing of varieties/hybrids of vegetable and field crops and other allied live material shall be done at the locations representing the specific agro-climatic zones of Jammu Division.

#### A. Hybrids/varieties which have not been tested through AICRP in this zone

##### 1<sup>st</sup> Year

The hybrids/varieties will be tested at two locations. Data on yield and other important agronomic characters, including reaction to diseases and pests shall be recorded under natural conditions. The data will be made available to the sponsor, who will inform whether or not to proceed further with the testing.

##### 2<sup>nd</sup> Year

The hybrids/varieties will be tested at two locations and recording of data will be as mentioned above.

##### 3<sup>rd</sup> Year

The hybrids/varieties will be tested at two locations and recording of data will be as mentioned above.

#### B. Testing procedures of hybrids/varieties which have been already tested through AICRP in this zone

The hybrids/varieties will be tested at two locations for one year. Data on yield and other important agronomic characters including reaction to diseases and pests under natural conditions shall be recorded and made available to the sponsor.

### 2. Testing procedure for chemicals/bioproducts

For testing agrochemicals (fungicides, insecticide, weedicides, etc.) and bio-products (bio-fertilizers, bio-pesticides, etc.) following procedure shall be adopted:

- i) The fee for new chemical or a brand of the chemical shall be charged for a trial to be conducted for one crop at a time.
- ii) The fee shall be charged for each agrochemical and bio-products separately.
- iii) The testing fee shall be obtained in advance before the start of testing procedure.
- iv) The new chemical/brand will be tested for two years at one location. The report to the funding agency will be sent only after the completion of the two years evaluation, through the Directorate of Research.

### General Instructions:

- HOD will be responsible for further nomination of the scientist for undertaking testing of products. The testing fees charged shall be kept at the disposal of the concerned Principal Investigator who shall be testing the product.
- The seed company shall give an undertaking that the hybrid/variety offered for testing is not genetically modified organism.
- Molecular data of parents and hybrids would be required to be submitted for authenticity of the variety/hybrid
- The evaluation report along with the data shall be submitted by the PI through proper channel to the Director Research for further communication to the concerned firm.
- The recording of data shall be undertaken as per the protocol submitted by the testing company.
- The material to be tested shall be supplied by the firm to the Director Research, who will send it to the concerned PI through Head. Any correspondence to be made thereafter with the firm will be made through the Director Research.
