#### (4) <u>Other detailed terms and conditions with regard to the appointment,</u> <u>domicile, reservation, etc. are as follows:-</u>

#### (I) Appointment of the candidates

(i) The condition of the probation, pay and allowances and fixation of the initial tenure of a person shall be governed as per SKUAST-Statutes.

#### (II) Domicile

- (i) The candidate should be a Domicile of the Union Territory of Jammu & Kashmir as defined in terms of the Notifications issued by the Ministry of Home Affairs, Government of India vide S.O 1229 (E) dated 31.03. 2020 and S.O 1245(E) dated 03-04-2020 read with Notification issued by the General Administration Department, Government of Jammu and Kashmir vide S.O. 166 dated 18-05-2020.
- (ii) The candidate must possess Domicile Certificate issued by the Competent Authority on the format prescribed for the purpose, on or before the last date of submission of online application form.

### (III) Reservation

- i) Reservation in categories shall be applicable as per Jammu and Kashmir Reservation Rules-2005 together read with S.O. 127 dated. 20th April, 2020.
- ii) The PWD candidates shall be provided horizontal reservation as applicable where PWD candidates are available.
- iii) Candidates are cautioned to note that in case a claim for reservation is made on the basis of false/fake/fraudulent certificate, he/she shall be debarred from the examination(s) conducted by the University, in addition to any other action as may be deemed appropriate.
- iv) A candidate seeking his/her consideration under Reserved Categories must ensure that he/she possess a valid Category Certificate as on or before the cutoff date of the submission of online application forms. Category certificates issued after the cutoff date shall in no case be entertained.

## (5) Important Instructions to the candidates

- The posts advertised through this notification are available at different KVK's functioning under the administrative control of SKUAST-J in different district of Jammu Division. The selected candidates shall have to serve in these KVK's only and they shall have no claim for transfer to the other constituent units of the University except KVK's.
- > The application will be accepted in the prescribed format in online mode through the University website *www.skuast.org.* No other means/mode of application will be accepted.
- The last date for receipt of application form as stipulated above, shall be cut off date for determining the eligibility for the post. Any qualification/experience acquired thereafter shall not be considered thereafter.
- Applications received without the prescribed fee shall not be considered and summarily rejected. No representation against such rejection will be entertained. Fee once paid shall not be refunded under any circumstances nor will it be adjusted against any other examination or selection.
- > The detailed modalities with respect to the selection procedure to the above said advertised posts shall be issued separately.
- > The applicants are advised carefully fill the details in the online application forms and the information/details so submitted shall be treated as final for the purpose of determining eligibility of the candidate and no claim, whatsoever in this account shall be entertained subsequently.
