Sub: Selection of Sh. Pawan Singh S/o Krishan Singh R/o Village Bhagwag Tehsil Bhagwah, District Doda, J&K (182202) as Assistant-cum-Typist / Dispatch / Receipt / Stationery / Store Clerk & equivalents.

- WHEREAS, University vide Notification No. 23 (Secy.) of 2024 dated 27.02.2024 issued the provisional selection list of sixteen (16) candidates for the post of Assistant-cum-Typist / Dispatch / Receipt / Stationery / Store Clerk & equivalents.
- WHEREAS, amongst the selected candidates, the candidature of Pawan Singh S/o Sh. Krishan Singh, listed at S.No. 12 under the RBA category, was kept withheld pending clarification from issuing authority about the authenticity of his graduation degree obtained through distance learning.
- WHEREAS, University vide no. 90 (Secy.) of 2024 dated 07.03.2024 issued the final selection list, but the position at S.No. 12 was still kept withheld pending the verification of the veracity of Degree certificates of aforesaid candidate.
- WHEREAS, the clarifications regarding authenticity of the Degree certificates and the recognition status of the university, were received from Vinayak Mission Research Foundation, Salem, Tamil Nadu and UGC, New Delhi vide communication No's VMRF/DDE/CV/7317 and F.No. 5-11/2024 (DEB-II) dated 24.05.2024, respectively. These clarifications were thoroughly reviewed by the Document Verification-cum-Selection committee, constituted AUJ/Secy/23-24/F-SLF-15/2797-2802 dated 12.02.2024, which then recommended the selection of Sh. Pawan Singh against the post of Assistant-cum-Typist / Dispatch / Receipt / Stationery / Store Clerk & equivalents.

Now, therefore, Sh. Pawan Singh S/o Krishan Singh R/o Village Bhagwag Tehsil Bhagwah District Doda, J&K (182202) is hereby selected for the post of Assistant-cum-Typist / Dispatch / Receipt / Stationery / Store Clerk & equivalents under RBA category in this university.

It is further notified that:

1. The above final selection shall be subject to outcome of writ petition, if any.
2. The selection of the candidate has been made on the basis of the Self declaration/Certificates submitted by the candidate and if at any stage, it comes to the light that candidate has submitted false information or has secured selection on the basis of fake documents/ certificates; his selection is liable to be cancelled in abinitio.

Further, in term of J&K Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021 together read with circular no. 18-JK(GAD) of 2022 dated 20.05.2022, the selected candidates, has to submit their **email address & mobile number** in the Office
