In reference to Advertisement No. 09 (Secy.) of 2023 dated 19.07.2023 and in continuation of University Order No. 349 (Secy.) of 2024, dated 14.11.2024, sanction is hereby granted for the selection of the following candidate as Apprentice Technician (Farms/Lab) T_1 in this University, by allowing her the benefits under RBA category, as per details given here under:

The selection of Apprentice Technician $(Farms/Laboratories)T_1$ shall be governed by following terms and conditions as per SKUAST Statutes in vogue and as shall come into force from time to time

- i) The aforestated Apprentice Technician (Farms/Lab) (T₁) shall have to undergo apprenticeship at various Farms/Laboratories of the University for a period of two year. Provided that the candidates who have already undergone one Year's training in Agriculture /Horticulture /Animal Husbandry and Allied fields in a recognized institute or held B.Sc. Degree shall undergo apprenticeship for a period of one year only.
- ii) The Apprentice shall have to pass the test prescribed by the University in order to complete the apprenticeship satisfactorily.
- iii) The period of apprenticeship shall be extendable by six months in special cases where a candidate fails to complete the same satisfactorily subject to a maximum of one year. Candidate failing to complete the apprenticeship satisfactorily within the prescribed time limit shall forfeit her claim for appointment and apprenticeship shall stand terminated at the expiry of the stipulated period.
- iv) The Apprentice Technician (Farms/Lab) T₁ shall receive stipend @ ₹3000/per month during the apprenticeship period against Salary Head account of the post against which the apprentice shall be adjusted.
- v) The Apprentice if found guilty of misconduct or deliberate disobedience of orders or who repeatedly refuses to conform to the procedure prescribed for the conduct of training shall be terminated from the Apprenticeship forthwith.

- vi) That after successful completion of the apprenticeship, the rules in vogue shall be applicable to the appointment of the successful apprentice against the post of Technician (Farms/Lab) T₁.
- vii) The above Apprentice Technician (Farms/Lab) T₁ shall submit her joining report physically to the Office of Registrar, SKUAST-Jammu within a period of 21 days, failing which the selection of the candidate shall be cancelled abinitio without any further notice.
- viii) The Selectee shall be allowed to join only on production of the following certificates in Original:
 - a) Academic Qualification Certificates.
 - b) Matriculation/Date of Birth Certificate.
 - c) Marksheet/Degree Certificate of all qualifying examinations.
 - d) the above apprentice are required to submit Medical Fitness Certificate issued by the Chief Medical Officer;
 - e) Domicile Certificate issued by the Competent Authority.
 - f) That if the candidate has taken any loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Center (DIC) and District Employment and Counseling Center of the domicile District, she shall relinquish the proprietorship of unit /enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the University Services. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a selfemployment unit/enterprise and recovery to be made and also personally monitor its recovery.
 - g) Relevant category certificate(s), (in case of candidates belonging to reserved categories).
 - h) Any other certificates/documents as required under rules/norms.
 - The apprentice shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:
 - a) if on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable) submitted by candidate is found forged, false or fake, her appointment shall be canceled ab-initio at the risk and responsibility of the concerned;
 - b) The stipend of the apprentice shall not be drawn and disbursed to her unless and until the satisfactory report/ genuineness of the certificates in respect of condition a) is received.
 - c) The apprentice has no criminal records and also is not facing any criminal proceedings in any court of law.
