- d) One original Photo ID Proof i.e. Aadhar card/PAN Card/Passport etc.
- e) D.O.B Certificate (10th Diploma /Marks card).
- f) Valid Reservation Category Certificate, if applicable.
- g) Domicile certificate.
- h) 10+2 Marks sheet /Diploma.
- i) Copy of the Essential qualification documents as per advertisement notification.
- j) Other documents as per the advertisement.
- k) Ex-serviceman (if applicable) :
 - i. Discharge Certificate, if discharged from the Armed Forces.
 - ii. An Ex-Serviceman shall be required to produce a certificate in form-XIV duly signed by the competent authority as provided in the rule 18 of Jammu and Kashmir Reservation Rules, 2005.
