# Sub:- Documents verification of candidates provisionally shortlisted for the posts of Driver advertised vide notification no. 09 (Secy.) of 2023 dated 19.07.2023

Sher-e-Kashmir University of Agricultural Science and Technology of Jammu vide notification No. AUJ/Secy./24-25/SLF-20/3257-59 dated 24.02.2025, issued the result of the candidates who appeared in the OMR Based Written Examination, held on 07.12.2024 for the posts of Driver advertised vide notification no 09 (Secy.) of 2023 dated 19.07.2023.

Accordingly, in view of the need and objective to fill all requisitioned vacancies, the candidates falling within the consideration zone (in the ratio of 1:1) for the aforementioned post, **as listed in Annexure-A of this notification**, are hereby called upon to appear in person before the designated Document Verification –cum-Selection Committee of the University for verification and scrutiny of their documents/certificates on **25.03.2025 at 11:00 AM** in the Meeting Hall of Registrar's Office, SKUAST-Jammu, Chatha, Jammu-180009. The candidates who fail to appear before the respective Documents Verification Committee on the scheduled date shall forfeit their right to selection.

It may be noted that mere figuring of name in list of provisional candidates for documents verification will not entitle the candidates to be included in the Selection List.

Further candidates, as annexed herewith, are required to carry the following original documents/certificates as well as photocopies of the following documents, duly self-attested by the candidate, before the designated Documents Verification Committee:

- 1. Copy of Online Application form and Admit Card/Roll No. Slip of written examination.
- 2. Two Passport size recent Colour Photograph.
- 3. One original Photo ID Proof i.e. Aadhar card/Voter Card/PAN Card/Passport etc.
- 4. D.O.B Certificate (10th Diploma / Marks card).
- 5. Valid Reservation Category Certificate, if applicable.
- 6. Valid Driving License (Heavy passenger Motor Vehicle)
- 7. Domicile certificate.
- 8. 10th Marks sheet /Diploma.
- 9. Other documents as per the advertisement.
- 10.Ex-serviceman(if applicable):
  - a) Discharge Certificate, if discharged from the Armed Forces

- b) An Ex-Serviceman shall be required to produce a certificate in form-XIV duly signed by the competent authority as provided in the rule 18 of Jammu and Kashmir Reservation Rules, 2005.
- c) No Objection Certificate, in case already employed in Government/ Government undertakings.
- 13. In case of candidates claiming possession of equivalent educational qualification, it shall be mandatory to produce relevant Equivalence Certificate from the J&K Board of School Education at the time of Documents Verification.
- 14. Bonafide certificate duly issued by the Controller/Registrar of the Concerned Board/Institute in respect of the candidates, who have obtained eligibility qualification from outside the Board.
