- 2. After filling up the application form, the form must be submitted with in stipulated time as per the details given below:
  - The requisite fee of Rs. 2000 (Rupees two thousand only) required to be paid only in shape of Bank Draft in favour of Comptroller SKUAST-Jammu, payable at Jammu.
  - ii. The application form, along with bank draft, complete in all respect duly supported by self-attested copies of all relevant documents, certificates and testimonials is to be submitted to the office of Registrar, Sher-e-Kashmir University of Agricultural Sciences and Technology of SKUAST-Jammu (SKUAST-J), Chatha, J&K-180009 by Speed post before the closing date for submission of application form. - iii. Application not accompanied with the prescribed fee will not be considered.
- iv. The in-service eligible candidates should forward their Application Forms through their employer. Applications not received through the Proper Channel are liable to be rejected. However, candidates are advised not to wait for the last date and an advance copy of the print out of the application form may be sent within the prescribed date followed by application through Proper Channel. All the in-service applicants are required to produce "No Objection Certificate" from the Competent Authority on or before the interview, failing which he/she shall not be allowed to appear in the interview.


vi. A separate application with separate fee required for each post. Application for two different posts should not be tagged together.
