University Order No: 41 (Secy.) of 2025

Sub:- Implementation of Judgment passed by the Central Administrative Tribunal, Jammu Bench in the case titled "Mohd. Kaif vs Union Territory of J&K & Ors".

- Whereas, University vide Notification No. 83 (Secy.) of 2024 dated 27.02.2024 issued the final selection list for the posts of Technician (Farms/Labs) T₁ advertisement vide Notification No. 09 (Secy.) of 2023 dated 19.07.2023.
- Whereas, in the final selection list issued by the University for the post of Technician (Farm/Lab) T₁, the name of Ms. Samiksha Sasan D/o Sh. Vijay Kumar, who was figuring under the PSP category in the provisional selection list issued vide No. 19 (Secy.) of 2024 dated 07.02.2024, was excluded, in view of filing of Writ Petition bearing WPC No. 153/2024 before the Hon'ble Court by a non-selected candidate namely Sh. Mohd. Kaif S/o Sajad Hussain under the Physically Handicapped category, claiming his entitlement to the said post in place of Ms. Samiksha Sasan.
- Whereas, in compliance with the directions of the Hon'ble Court, the University reserved one (01) post of Technician (Farm/Lab) T₁ under the PSP category, against which Ms. Samiksha Sasan was provisionally selected, till the final outcome of the writ petition filed by the non-selected candidate, namely Sh. Mohd. Kaif, is decided.
- Whereas, the aforesaid writ petition was transferred to the Hon'ble Central Administrative Tribunal, Jammu Bench, and was re-numbered as T.A. No. 136/2024, which has since been disposed of. The operative part of the judgment is reproduced as under:

"14. In view of the above discussion, we find no infirmity or illegality in the provisional selection list dated 19.12.2023, warranting interference under Article 226 of Section 14 of the Administrative Tribunals Act, 1985. The writ petition is devoid of merit and is liable to be dismissed.

15. Accordingly, TA is dismissed. No Costs".

In light of the foregoing facts and the judgment passed by the Hon'ble Central Administrative Tribunal, Jammu Bench, Ms. Samiksha Sasan D/o Sh. Vijay Kumar R/o Village Balshama, Tehsil Sunderbani, District Rajouri-185152 is hereby selected against the post of Technician (Farms/Labs) T₁ kept reserved by the University under PSP category. It is further notified that:

1. The above Selection List shall be subject to outcome of writ petition, if any.
2. The Selection of the Candidate has been made on the basis of the Self declaration/Certificates submitted by the candidate and if at any stage, it comes to the light that the candidate has submitted false

information or has secured selection on the basis of fake documents/
certificates; her selection is liable to be cancelled in abinitio.

Further, in term of J&K Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021 together read with Circular No. 18-JK(GAD) of 2022 dated 20.05.2022, the selected candidate has to submit their **email address & mobile number** in the Office of the Registrar, SKUAST-Jammu for registration under **"Employee Verification System (EVS)"** either in person or through email for verification of character and antecedents within a period of 10 days positively from the date of issuance of this notice.

The formal appointment order in favour of the selectee shall be issued separately only after receiving Character Antecedent from the concerned department in her favour.
