The candidates of the rank mentioned above, before attending the 3rd round of counselling must ensure that the following conditions are strictly adhere, failing which the Admission cum Counselling Committee shall be within its rights not to consider any request, in case of deviation of these conditions.

1. The candidates having opted for Biotechnology shall be initially offered the seat on merit basis obtained in CET-2018. In case seat still remains vacant after exhausting the list of candidates, these seats shall be filled from the candidates who has appeared in CET 2018 but not opted for B.Tech. (Biotechnology) at the time of filling of forms and are now interested to join B.Tech. (Biotechnology). However, this selection shall be based strictly on rank of candidates obtained in CET-2018.
2. The candidates attending counselling shall have to produce documents viz. Matric (D.O.B), Marks card of 10+2, Permanent Residence Certificate, Migration Certificate, Category Certificate, (if belonging to any reserved category), in original along with self attested photo copies of the all the above documents, admit card of SKUAST-J CET-2018 and 06 Nos. of recent passport size coloured photographs.
3. The candidates before attending the counselling on the aforesaid date shall have to deposit Rs. 1000/- (Non-refundable) as counselling fee through online mode one day before or on counselling date upto 10.00 A.M. For details in this regard log on www.skuast.org.
4. The selected candidates shall have to deposit requisite fee immediately after allocation of seat on the day of counselling positively. Therefore the candidates are advised come prepared for the same. For the fee structure visit information brochure CET-2018 available on the University website.
5. The candidates provisionally selected/admitted under self-financing and NRI/NRIs sponsored category shall have to execute an undertaking to the extent that he/she is in a position to pay the self-finance category fee for the whole duration of the degree programme and shall not request for any concession/exemption of fee at any point during the course of degree programme.
