**Sub: Provisional Admission to B.Sc. (Hons.) Agriculture & B.Tech. Biotechnology Programme for the academic session 2018-19.**

Consequent upon the third round of counselling held on 04-08-2018 and recommendations of the Admission cum Counselling Committee and approved by the competent authority, candidates who have deposited the prescribed fee as per the list (stream wise) enclosed as annexure-I and annexure-II to this notification are granted provisional admission in the academic session 2018-19, subject to the condition that if at any point of time during the course of study programme, information furnished by a selectee is found incorrect or misrepresented/concealed or suppressed in any form in such case the admission granted would be cancelled forthwith and this University shall be at liberty to initiate the necessary action under rule against such selectee.

The candidates are advised to report to the office of the Registrar on or before 16-08-2018 between 10:30 A.M to 4:00 P.M along with the original certificates, two sets of photocopies self attested testimonials and 3 Passport size photographs for filling up of the admission form (which shall be downloaded from the University website). The candidates thereafter shall report to the concerned Dean of the Faculty for registration in the 1<sup>st</sup> year /1<sup>st</sup> semester of the academic session 2018-19 on 16-08-2018, failing which his/her admission shall be treated as cancelled.

The selectee who have attended the counselling, but has not paid the prescribed fee placed as annexure-III to this notification, his /her selection shall be treated as cancelled and the seat in that case be declared as vacant/unfilled, which subsequently shall be filled from the waiting /next round of counselling, as the case may be. The provisional waiting list of third round of counselling for B.Sc. (Hons.) Agriculture under self finance category is placed as annexure-IV to this notification.


