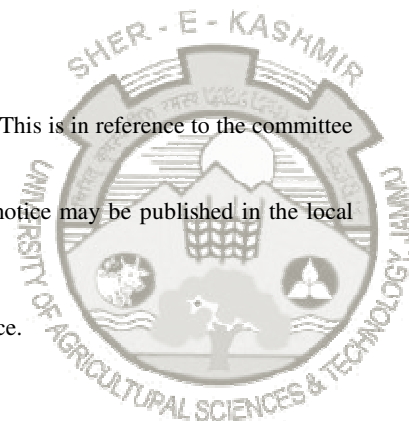
Terms and conditions

1. Any offer without CDR shall not be entertained.
2. The rates should be quoted on per quintal basis
3. Conditional bids shall be rejected out rightly.
4. The cost of gunny bags for lifting the grains will be over and above the bid amount.
5. Envelope containing the bid amount be labeled as "BID FOR AUCTION OF GRAINS".
6. 80% amount of the accepted bids shall have to be deposited within five days of acceptance of the bid and 20% before lifting the material.
7. The successful bidders shall have to lift the grain within seven days after depositing the full amount and the University shall not be responsible for any kind of damage whatsoever thereafter.
8. The quantities mentioned above are approximate and can vary.
9. The auction committee reserves the right to accept or reject any tender without assigning reasons thereof
