For and on behalf of Vice Chancellor, SKUAST-J, sealed bids affixed with revenue stamp of **Rs. 5/-** (Rupees five only) along with Call Deposit Receipts of **Rs. 5000.00** (Rupees Five thousand only) pledged in favour of “**Comptroller, SKUAST-J**” are invited from intending persons/agencies/mills for disposal of the following paddy grains on “*As is where is basis*” lying at Seed Store of Division of Agronomy, Chatha.

The sealed bids on prescribed forms addressed to the **Prof. & Head, Division of Agronomy FoA, SKUAST-J, Chatha-180009** should reach by speed or registered post in his office on or before **20th March, 2019** up to **2:00 p.m.** and shall be opened on the next working day at 12.00 noon in Division of Agronomy. The produce can be inspected on any working day during office hours except gazetted holiday/Saturday/Sunday at Seed Store of Division of Agronomy, Chatha. Terms and conditions:

1. Any offer without CDR shall not be entertained.
2. The bidder can inspect paddy grain lots lying at Division of Agronomy, SKUAST-Jammu, Chatha, on any working day during office hours except gazette holiday/Saturday/Sunday.
3. The offer should include cost of gunny bags also.
4. Envelope containing the bid amount should be labelled as “**BID FOR AUCTION OF PADDY GRAINS**”.
5. 80% amount of accepted bids shall have to be deposited within 3 days of acceptance of the bid and rest 20% before lifting the material.
6. The successful bidder shall have to lift the auctioned materials within 5 days of issuance of authorization and university shall not be responsible for any kind of damage to the auctioned material whatsoever thereafter.
7. The successful bidder who fails to lift the auctioned materials within stipulated time, the next higher bidder shall be offered to lift the material on highest bid.
8. The quantities mentioned above are approximate and may vary.
9. The Auction committee reserves the right to accept or reject any tender without assigning any reasons thereof.
10. The bid for basmati-370 and pusa-1121 shall not be below Rs. 3700/q and 3000/q., respectively.
11. The disputes, if any, shall be subjected to the jurisdiction of the Hon’ble courts located in the municipal limits of Jammu city only.
