



# Sher-e-Kashmir University of Agricultural Sciences and Technology of Jammu

Whereas, Sh. P. D. K. Uppal was appointed as apprentice Accounts Assistant in terms of erstwhile SKUAST communication No. AU/Adm/IV/A-2/86/4142-67 dated 15-05-1987 and he joined at RARS R. S. Pura. He was deputed for undergoing ACC training at Northern Zonal Accountancy Training Institute (NZATI) vide No. AU/Accts/F-Estt/87-88/839-50 dated 01-06-1987 figuring at S. No. 9.

Whereas, Sh. Uppal passed the ACC examinations vide notification No. DAT/ACC/88 of 1988 dated 18-07-1988 issued by Finance Department Govt. J&K figuring at S. No. 9.

Whereas, Sh. Uppal was appointed as Accounts Assistant vide University Order No. 239(Est.) of 1989 dated 18-05-1989 in the erstwhile SKUAST and posted at RARS Rajouri. He was figuring at Sr. No.43 as per tentative seniority list of Accounts Assistants issued by the erstwhile SKUAST vide No. University Order No. 239(Est.) of 1989 dated 18-05-1989.

Whereas, Sh. Uppal was transferred to RARS Kargil vide erstwhile SKUAST University Order No.91 Est.-J (Est.) of 1998 dated 17.07.1998.

Whereas, erstwhile SKUAST was bifurcated into two Universities viz. SKUAST-Kashmir and SKUAST-Jammu vide Agriculture Production Department communication No. Agri-SKUAST/48/99 dated 20.09.1999.

Whereas, employees were not given the opportunity to opt for services of either of the Universities with the result, Sh. Uppal remained in SKUAST-Kashmir instead of his home town University i.e. SKUAST-Jammu.

Whereas, he was promoted as Accountant vide U. O. No. 635(Est.) of 2006 dated 06-09-2006 of SKUAST-Kashmir and posted in the office of Comptroller SKUAST-Kashmir.

Whereas, in reference to Governor's Sectt. letter No. GS-32(M-Trans) AUK/09-14/5064-65 dated 09-12-2014, Sh. P. D. K. Uppal was transferred from SKUAST-Kashmir to SKUAST-Jammu in terms of Section 50-D of SKUAST amendment Act 2005 and relieved by the Comptroller SKUAST-Kashmir to join SKUAST-Jammu for further duties vide No. AU/Compt/PA/M-5/15/6638-44 dated 13-01-2015.

Whereas, the name of Sh. P. D. K. Uppal was not figuring in the seniority list of Accounts Assistants/Accountants issued by SKUAST Jammu vide Circular No: AUJ/Est./G-438(II)15-16/2270-2326 Dated 24-08-2015 as he was in SKUAST-Kashmir.

Whereas, his juniors in SKUAST-Jammu were given all promotion benefits from time to time on due dates by virtue of bifurcation of SKUAST-Jammu from erstwhile SKUAST vis-à-vis creation of new positions of Accounts personnel in SKUAST- Jammu.

Whereas, Sh. Uppal requested for restoration of his seniority as per his erstwhile SKUAST position vide his representation dated 05.02.2018 recommended by the Director Research vide No.DR/8057 dated 12.02.2018.

Whereas, a committee was constituted vide University Memorandum No.AUJ/Est./P-2/2018-19/3359-65 dated 13-09-2018 to examine the Seniority claim of Sh. P. D. K. Uppal Accountant.

Whereas, the said committee after examining the case, as per the minutes of the meeting issued vide no. AUJ/Est./F-G-390-D(3)/18-19/5423-32 dated : 22 .11.2018 recommended that the seniority of Sh.P.D.K. Uppal may be fixed as Accountant from the date of his promotion in SKUAST-Kashmir vide University Order No.635(Est.) of 2006 dated 06.09.2006 w.e.f. 06.09.2006. His subsequent placement as Accountant (Selection Scale) in the pay band of 9300-34800+GP 4200 may be considered from the due date i.e. 06.09.2009 as per SKUAST Statutes Schedule-II to Chapter-III (Accounts Cadre) class-III category-I subnote-1 on notional basis from 06.09.2009 to 18.02.2015 and with financial benefits, if any from 19.02.2015 onwards i.e. the date of issuance of Notification No.05(Secy.) of 2015 dated 19.02.2015 regarding up-gradation of 02(two) posts of Accounts Assistant as Accountants.

In light of above, the seniority of Sh. P. D. K. Uppal is fixed as Accountant in SKUAST-Jammu w.e.f. 06-09-2006 and placed as Accountant Selection Scale in the pre-revised pay band of 9300-34800+GP 4200 w.e.f. 06.09.2009 as per SKUAST Statutes Schedule-II to Chapter-III (Accounts Cadre) class-III category-I subnote-1 on notional basis from 06.09.2009 to 18.02.2015 and with financial benefits, if any from 19.02.2015 onwards i.e. the date of issuance of Notification No.05(Secy.) of 2015 dated 19.02.2015 regarding up-gradation of 02(two) posts of Accounts Assistant as Accountants.


