- Whereas, on the recommendations of the Selection Committee and approval of the Competent Authority among others Sh. Ajay Kumar S/o. Hans Raj R/o. H.No. 396/B, Sector 1, Durga Nagar, PO Roop Nagar, Jammu was appointed as Apprentice Field-cum-Laboratory Assistant in Open Category vide University order no. 50 (Secy.) of 2018 dated 25.04.2018.
- Whereas, as per the terms and conditions laid in the aforesaid University order, Sh. Ajay Kumar S/o. Hans Raj R/o.
