



# Sher-e-Kashmir University of Agricultural Sciences and Technology of Jammu

University Order No: 71 (Secy.) of 2018

Dated: 11-07-2018

Consequent upon the issuance of notification no's 15 (Secy.) of 2018 dated 11.07.2018 and 16 (Secy.) of 2018 dated 11.07.2018 based on the recommendations of Board of Management of SKUAST-Jammu (at its 28<sup>th</sup> meeting) and approval of University Council (at its 17<sup>th</sup> Meeting), assented to by the Hon'ble Chancellor (Hon'ble Governor, J&K), it is hereby ordered that:

1. The Subject Matter Specialists (SMS's) in KVK's of SKUAST-Jammu presently in the grade pay ₹5400 is deemed to have been appointed in the academic pay grade ₹6000, instead of ₹5400 notionally from the date of their respective appointments and prospectively from the issuance of above relevant University notifications.
2. The future financial liabilities related to difference of grade pay from ₹5400 to ₹6000 shall be borne by the university resources without creating any financial liability on state exchequer from the date of its applicability.
3. All the future appointments of SMS in KVK's of SKUAST-Jammu shall be made uniformly in the pay band of ₹6000.
4. The promotees Research Assistants/Sr. Technical Assistants/Programme Assistants & equivalents as and when caderised/accredited equivalent to the post of Subject Matter Specialists (SMS) shall be adjusted instantly against the available posts of Subject Matter Specialist in KVKs, subject to fulfilling of all eligibility criteria/qualification as prescribed for the post of SMS .
5. The transfer of staff appointed on the available position of KVK shall be made within KVKs only and all the employees promoted/upgraded /appointed shall be governed strictly as per KVK norms prescribed by ICAR from time to time including the promotes Research Assistants/Sr. Technical Assistants/Programme Assistants & equivalents as mentioned at S.No. 4.
