Jammu, the 11th January, 2018.

SRO 12 . - In exercise of the powers conferred by proviso to section 124 of the constitution of Jammu and Kashmir, the Governor hereby makes the following amendment in the Jammu and Kashmir Civil Service Regulation -Vol-II; namely:-

sub-rule (j) of rule 5 of Schedule XXIII of Jammu and Kashmir Civil Service Regulations, 1956 Vol-II shall be substituted by the following:-

"Deduction towards G.P. Fund contribution from the Government Servants joining service on or after 01.01.2010, who are on New Pension Scheme, shall be allowed on voluntary basis. It shall be compulsory for the employees to have G.P. Fund accounts with assigned G.P. Fund numbers. However, regular monthly subscription to the fund shall not be compulsory for employees on New Pension Scheme."
