



## Sher-e-Kashmir University of Agricultural Sciences and Technology of Jammu

On the recommendations of the University Promotion Committee and approved by the Hon'ble Vice-Chancellor, Sh. Suresh Kumar, OCC Division of Agro-forestry FoA and Sh. Subash Chander, OCC Directorate of Extension possessing Class VI Category 4 of SKUAST Statutes Schedule III to Chapter III (Auxiliary Staff Cadre) are hereby promoted as Field-cum-Laboratory Assistant FCLAs and placed on apprenticeship probation for a period of two years extendable in special case for a period of six months subject to a maximum of one year with immediate effect.

The apprentice FCLAs shall draw their salary in their own pay and grade with ₹150/- per month as training allowance during the period of apprenticeship probation. The pay and training allowance of such apprentices shall be debited to the salary head of account of the particular post against which the apprentice is adjusted.

The promotee Field-cum-Laboratory Assistants shall be placed in the regular time scale of FCLAs only after satisfactory completion of the apprenticeship probation, failing which they shall revert to their original posts from where promoted. Satisfactory completion of apprenticeship probation will include passing of a test prescribed by the University. In case the promotees have already undergone one year training, they will be required to undergo apprenticeship only for one year. The detailed guidelines for undertaking the apprenticeship shall be issued separately.

Consequent upon the above promotion, the following apprenticeship FCLAs are hereby deployed at the following places:


- **Sh. Suresh Kumar is posted against the available post of FCLA in the ACRA Dhiansar.**
