1. To produce the Medical/Health Certificate duly issued by Competent Authority to the extent that you are of sound health, active habits and free from any bodily defects or infirmity unfitting you for above appointment.
2. To produce the following original documents /certificates in original:-
 - a) Academic/Technical Qualification Certificates in original.
 - b) Matriculation/Date of Birth Certificate.
 - c) Health Certificate issued by the Chief Medical Officer (as above at S.No. 1).
 - d) Permanent Resident Certificate issued by the Competent Authority.
 - e) Category Certificate, if any.
 - f) Certificates from the concerned (Deputy Director, Employment and General Manager, DIC) to the effect that no loan under self-employment scheme has been taken by you.
 - g) to give an undertaking in the shape of an affidavit to the effect that in case adverse report about your character and antecedents is received from the Inspector General of Police, (CID), J&K, to whom a reference shall be made by the University, shall have no right to claim your continuance as Assistant Manager (Guest House) and as such, shall be deemed to have been cancelled ab-initio.
 - h) Verification/Genuineness of the qualification certificates from the concerned issuing authorities. If, at any stage, the same are proved wrong/fake, then your appointment is liable to be cancelled automatically without any notice.
3. On probation for a period of 05 (years) from the date of joining on the post. During the probation period you shall be entitled to draw pay plus grade pay without any further allowances in term of existing rules of SKUAST-Statutes together read with Clause 15 (Method of recruitment) sub-clause

- c) (a-e) of Chapter-III (Recruitment of employees other than officers and teachers of the University) of SKUAST-Statutes (at par with SRO-202 of 2015 dated 30.06.2015). You shall be entitled for fixation of pay in the scale of pay applicable to the post only after completion of 05 years of satisfactory probation.
4. Failure to complete the period of probation to the satisfaction of the University will render you liable to discharge from service without assigning any reason thereof.
 5. Your appointment/service conditions shall be governed under the existing rules as prescribed under the relevant recruitment/service rules of SKUAST-Statutes/JKCSR (wherever applicable) along with the amendments made from time to time.
 6. Your pay shall not be drawn and disbursed to you unless the satisfactory reports in respect of 2(g) and 2(h) above are received in your favour.
 7. Your appointment shall further be subject to the outcome of Writ Petition(s), if any, pending before any court of competent jurisdiction.
 8. You shall be posted in any constituent unit of the University.
 9. Selection secured on any wrong information submitted by you to this university shall lead to termination of appointment/selection at any stage of time without serving any notice.
 10. The offer of appointment is valid for 21 days from the date of issuance and you have to submit your acceptance along with requisite documents within the stipulated time failing which the offer of appointment in your favour shall be treated as cancelled and the next candidate shall be considered for offer of appointment.
 11. The appointment order in your favour shall be served after due approval of the Competent Authority only after accepting/fullfilling all the terms and conditions as laid down in the offer letter.
