### NOTIFICATION

- 1) It is for the information of all the concerned eligible applicants who have applied for the post of Field-cum-Laboratory Assistant (FCLA)/Live Stock Assistant (LSA) advertised vide notification no. 13 (Secy.) of 2016 dated 05.09.2016 that the combine Written/Screening test for the posts shall be conducted on 27<sup>th</sup> of January, 2018 at 10:30 AM in the Examination Halls/class rooms of Faculty of Agriculture, SKUAST-J, Chatha.
- 2) The final list of the eligible candidates is available on the official web site of SKUAST-J i.e. [www.skuast.org](http://www.skuast.org).
- 3) The eligible Candidates can download their individual admit cards through a link available on the university website i.e. [www.skuast.org](http://www.skuast.org) w.e.f. 20.01.2018 onwards. However all those eligible candidates whose name figure in the list of eligible candidates in FCLA's and LSA's already uploaded on website but are unable to download the admit card, may report to I/C Examination Cell, SKUAST-J, Chatha at least two days prior to the date of Written/Screening. The candidates are informed to strictly follow the instructions given in the admit card, which shall be final and binding for the candidates.
- 4) No separate mode of communication shall be followed for calling the candidates for appearing in the written/screening test.
- 5) It is further informed to the candidates who are appearing in combine Written/Screening test for both the posts i.e. FCLA and LSA, the list of candidates in order of merit to be obtained in the Written/Screening test shall be displayed separately for both these positions and shortlisting candidates to be called for appearing in the interview shall be done on the basis of merit score of Written/Screening test in the ratio of 1:5 against the number of positions advertised separately for FCLA and LSA respectively.
- 6) The candidates of Biology and Math streams shall have the choice to opt for questions set from one stream only depending upon the stream he/she have passed in the academic prescribed qualification.
- 7) The additional qualifications/experience certificate acquired, if any, by the candidate after the last date of receipt of application forms shall not be entertained at any cost.
- 8) Relevant experience related to post shall be counted for awarding the experience marks by the academic score committee wherein the candidates have served in Govt. Organization/PSU's/Autonomous bodies only, experience of which shall be considered thereof only. Candidates are required to bring the following document duly authenticated by the employer at the time of interview:

*"Certificate by the employer that he/she has worked on the Job (description of job to be recorded) which was of FCLA/LSA related posts from \_\_\_\_\_ to \_\_\_\_\_. Certified that his/her actual pay as per acquaintance roll of our organization is as under:"*

***(The decision of selection committee for considering the experience in the relevant field shall be final and binding)***

- 9) The shortlisted candidate shall have to produce all original certificates/testimonials as asked for vide above referred advertisement

- 10) The nature of appointment, fixation of pay and increments, DA and other allowances/other service conditions shall be applicable as contained in the SRO-202 of J&K Govt. to the candidates selected against the advertised posts irrespective of terms and conditions envisaged in earlier advertisement made for above said posts
- 11) Any candidate found guilty of impersonating or submitting fabricated/ tampered documents/testimonials or making false, incorrect or suppressing material information shall render him/her liable for criminal prosecution under law and may be debarred permanently or for a specific period for consideration of any or all future recruitments made by the University. Also canvassing / lobbying in any form will entail disqualification of the candidate.

### NOTE:-

- No TA / DA shall be paid by the University for appearing in the Written/Screening test.
- All the candidates must bring the admit card along with any of the photo identity proof such as Passport / PAN Card / Driving License / Voter's Card / Bank Passbook with duly attested photograph / Unique Identification Card (Aadhaar) in original. Please note that his/her name as appearing on the admit card (provided by applicant in the application form) should exactly match with the name as appearing on the photo identity proof. If there is any mismatch between the name indicated in the admit card and Photo Identity Proof he/she will not be allowed to appear for the exam.
- The candidates must bring blue or black ball point pen with him to the examination hall.
- Use of books, notebooks, calculators, cell phones etc. are not permitted inside the premises of the examination halls. It is advised not to bring any of the banned items including cell phones to the test venue, as arrangement for safekeeping of these items cannot be assured and shall be at risk & responsibility of the candidates.
- The eligible candidates are informed to strictly follow the instructions as inscribed on the admit card, which shall be final and binding for the candidate/candidates.
