- I. The engagement of above staff will be purely on contractual basis co-terminus with the GKMS project on year to year extension basis to be granted by IMD, depending upon the performance of the candidate.
- II. The above posts are for Krishi Vigyan Kendra Reasi and Krishi Vigyan Kendra Kathua.
- III. The candidates shall have no legal right to claim his/her regularization/appointment by absorption or otherwise against any regular post in SKUAST-Jammu or any further contractual engagement.
- IV. The appointees are eligible for annual increment along with service extension based on review of their annual performance.
- V. No Objection Certificate from the employer in case of engagement elsewhere and experience certificate, relevant to the project, in original, if any will be produced at the time of interview.
