### **NOTIFICATION**

- 1) It is for the information of all the concerned eligible applicants for the post of **Accounts Assistant/Cashier** applied against advertisement notification no. 12 (Secy.) of 2012 dated 25.09.2012 & 08 (Secy.) of 2015 dated: 05.05.2015 that the Written/screening test for the post shall be conducted on **17<sup>th</sup> of June, 2017 at 10:30 AM** in the Examination Halls/Class rooms of Faculty of Agriculture, Chatha and Faculty of Veterinary Science & AH RS Pura, SKUAST-J, Chatha/RS Pura, SKUAST- Jammu.
- 2) The final list of the eligible candidates is available on the official web site of SKUAST-J i.e. [www.skuast.org](http://www.skuast.org).
- 3) Candidates are required to submit the shortfall documents at least one day prior to screening/written test., if any, as shown in the eligibility list already uploaded on university website otherwise they would not be allowed to appear in the written/screening test.
- 4) Individual admit cards to the eligible candidates have been sent through Registered/Speed post **besides a link has also been provided on the website ([www.skuast.org](http://www.skuast.org)) for downloading the admit card.** However, all those eligible candidates whose name figure in the list of eligible candidates but have not received the admit card or is unable to download the admit card, may report Registrar Office, SKUAST-J, Chatha at least one day prior to date of Written/Screening test.
- 5) The additional qualifications/experience certificate acquired, if any, by the candidate after the last date of receipt of application forms shall not be entertained at any cost.
- 6) The shortlisted candidate shall have to produce all original certificates/testimonials as asked for vide above referred advertisement notification before the selection committee at the time of interview. The candidates who fail to produce such certificates/testimonials may forfeit their candidature.
- 7) Any candidate found guilty of impersonating or submitting fabricated/ tampered documents/testimonials or making false, incorrect or suppressing material information shall render him/her liable for criminal prosecution under law and may be debarred permanently or for a specific period for consideration of any or all future recruitments made by the University. Also canvassing / lobbying in any form will entail disqualification of the candidate.

#### **NOTE:-**

- No TA / DA shall be paid by the University for appearing in the Written/Screening test.
- All the candidates must bring the admit card along with any of the photo identity proof such as Passport / PAN Card / Driving License / Voter's Card / Bank Passbook with duly attested photograph / Unique Identification Card (Aaadhaar) in original. Please note that his/her name as appearing on the admit card (provided by you in the application form) should exactly match the name as appearing on the photo identity proof. If there is any mismatch between the name indicated in the admit card and Photo Identity Proof he/she will not be allowed to appear for the exam.
