In case, the representation is not received in this office within the prescribed period of one month, it would be considered that there is nothing to say against the seniority issued as above.*
- II. *The date of birth mentioned against the employees in the Seniority List shall not be taken as authentic and shall be subject to the further authentication from the concerned issuing authority(ies) commensurating with the entries recorded in individual Service Books/Matriculation /Date of Birth Certificates issued by the concerned authorities.*
