The appointee shall report to the office of the Registrar with in a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:

- i. All Academic qualification certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate issued by the Chief Medical Officer.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Unmarried Certificate issued by the Competent Authority.
- vi. Certificate from the concerned office (Deputy Director, Employment and General Manager, DIC) to the effect that no loan under self-employment scheme is pending against the selectee.

The appointment of the appointee, shall further be subject to the following conditions:

- (a) The appointee shall give an undertaking in the shape of an Affidavit to the effect that if on verification, her Qualification/Date of Birth from the concerned issuing authorities is found fake/forged her appointment as Peon shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- (b) The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth is received from the concerned authorities/agency.

- (e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (f) If the appointee fail to join within a period of 21 (twenty one) days from the date of issuance of this order she shall forego her right of appointment which shall be deemed to have been cancelled ab-initio without any further notice.
