- WHEREAS, SKUAST-Jammu vide Notification No. AUJ/Secy./23-24/SLF-15/2283-85 dated 01.12.2023 issued the Result of Computer Based Type Test (Skill Test) for the Post of Assistant-cum-Typist/Dispatch /Receipt /Stationery /Store Clerk and equivalents held w.e.f. 1st of November, 2023 to 10th November, 2023 at NIELIT, Jammu.
- WHEREAS, SKUAST-Jammu conducted OMR based written test on 30.12.2023 at SKUAST-Jammu, Chatha, in respect of those candidates who qualified the Type Test for the post of Assistant-cum-Typist/Dispatch /Receipt /Stationery /Store Clerk and equivalents.
- WHEREAS, on the basis of performance of the candidates in OMR based Objective Type Written Test Examinations, the results of the candidates appeared in written test was declared vide no. AUJ/Secy./23-24/SLF-15/2732 dated 30.01.2024.
- WHEREAS, the declaration of the result was followed by the Document Verification (DV) of the candidates falling under consideration zone, vide notification no. AUJ/Secy./23-24/SLF-15/2745 dated 06.02.2024, by Document Verification-cum-Selection committee constituted for the purpose.

In case, any candidate, who fails to submit his/her email address & mobile number within a period of 07 days, it shall be presumed that the candidate is not willing to opt for such appointment in the University.
