The appointment of the above Selectee shall be governed by the following terms and conditions:

1. The appointee shall be allowed to join on the post only after receiving the Character Antecedent Verification from the concerned department in his favour, in term of J&K Government Order No. 528-JK (GAD) of 2021 dated 21.06.2021 together read with circular no. 18-JK (GAD) of 2022 dated 20.05.2022 and 05-JK (GAD) of 2024 dated 18.01.2024. The selected candidate, has to submit his **email address & mobile number** in the Office of the Registrar, SKUAST-Jammu for registration under "**Employee Verification System (EVS)**" email **recruitmentteachingskuastj@gmail.com** for verification of character and antecedents within a period of 7 days positively from the date of issuance of this order. In case, any candidate, who fails to submit his email address & mobile number within a prescribed period of 7 days, it shall be presumed that the candidate is not willing to opt for such appointment in the University.
2. The formal appointment order in favour of the above selectee shall be issued separately only after receiving Character Antecedent from the concerned department in his favour.
3. The appointee after joining his respective place of posting shall be on probation for a period of two years from the date of joining on the post.
4. During the period of probation, the appointment can be terminated by the University at any time without issuing any notice or assigning any reason thereof.
5. The appointee can be posted in any constituent unit of SKUAST-J as and when required.
6. The service conditions of the appointee shall be governed in accordance with the SKUAST-Jammu Statutes and rules of the University as are in force with amendments or as may come into force from time to time, together read with provisions of J&K CSR, wherever applicable.



7. If any declaration given or information furnished by the appointee, proves to be false or the appointee is found to have willfully suppressed any material information, he shall be liable for removal from service and such other action as may be deemed necessary.
8. If any document and/or certificate submitted by the appointee is found or forged or fake in any way at any point of time, the appointment shall be cancelled *ab-initio* at the risk and responsibility of the concerned.
9. The appointee shall be required to submit Medical Fitness Certificate from the concerned designated Authority.
10. If upon verification, to be received from the concerned issuing authorities, to whom a reference shall be made by the concerned office (under confidential cover), the qualification certificates and/or other documents submitted in support of his/her candidature/ Scorecard is /are found to be fake/forged, the claim of the appointee for appointment as Professor-cum-Chief Scientist shall be deemed to have been canceled *ab-initio* and legal action as warranted under rules shall also be initiated;
11. The appointment shall be without prejudice to the outcome of writ petition(s), if any, pending before any competent Court of Law.
