 - During the period of probation, the appointment can be terminated by the University at any time without issuing any notice or assigning any reason thereof.
 - The appointee can be posted in any constituent unit of SKUAST-J as and when required.
 - 5. The service conditions of the appointee shall be governed in accordance with the SKUAST-J Statutes and rules of the University as are in force with amendments or as may come into force from time to time, together read with provisions of J&KCSR, wherever applicable.
 - If any declaration given or information furnished by the appointee, proves to be false or the appointee is found to have willfully suppressed any material information, he shall be liable for removal from service and such other action as deemed necessary.
 - 7. If any document and/or certificate submitted by the appointee is found to be forged or fake in any way at any point of time, the appointment shall be cancelled *ab-initio* at the risk and responsibility of the appointee.
