Sub:- Final Selection lists of candidates for the posts of (i) Electrician (ii) Sound Man (iii) Carpenter and (iv) Works Supervisor (Civil) advertised vide notification no. 09 (Secy.) of 2023 dated 19.07.2023.

- WHEREAS, University, vide Notification no. 09 (Secy.) of 2023 dated 19.07.2022, advertised the following non-teaching posts, with the category wise break up as under:

- WHEREAS, SKUAST-Jammu vide Notification No. 22 (Secy.) of 2024 dated 16.02.2024 under endorsement no. AUJ/Secy./23-24/SLF-16/2880-82 dated 16.02.2024 issued the Result of Skill Tests of above said posts held w.e.f 29.01.2024 to 05.02.2024 at Industrial Training Institute (ITI), Govt of J&K, Akhnoor Road, Pillar no. 10, Shakti Nagar, Jammu.
- WHEREAS, SKUAST-Jammu conducted OMR based written tests on 05.03.2024 for the posts of Electrician, Works Supervisor (Civil) & Carpenter and on 11.03.2024 for the post Sound Man at SKUAST-Jammu, Chatha, in respect of those candidates who qualified the Skill Tests of above said posts advertised vide notification no. 09 (Secy.) of 2023 dated 19.07.2023 .
- WHEREAS, on the basis of performance of the candidates in OMR based Objective Type Written Test Examinations, the result of the candidates who appeared in written tests for the posts of **(i) Electrician (ii) Sound Man (iii) Carpenter and (iv) Works Supervisor (Civil)** was declared vide Notification No. AUJ/Secy./23-24/SLF-16/541 dated 18.04.2024.
- WHEREAS, the declaration of the result was followed by the Documents Verification (DV) of the candidates falling under consideration zone, vide notification no. AUJ/Secy./23-24/SLF-16/826-27 dated 16.05.2024, by Selection-cum-Documents Verification committee constituted for the purpose.
- WHEREAS, on the recommendations of Documents Verification-cum-Selection committee, University notified the provisional Selection Lists for the post(s) of **(i) Electrician (ii) Sound Man (iii) Carpenter and (iv) Works Supervisor (Civil)** vide notification no. 06 (Secy.) of 2024 dated 04.06.2024.


1. The above Final Selection Lists shall be subject to outcome of writ petition, if any.

Further, in term of J&K Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021 together read with circular no. 18-JK(GAD) of 2022 dated 20.05.2022, the selected candidates, have to submit their **email address & mobile number** in the Office of the Registrar, SKUAST-Jammu for registration under "**Employee Verification System (EVS)**" either in person or through email for verification of character and antecedents within a period of 07 days positively from the date of issuance of this notice. In case, any candidate, who fails to submit his/her email address & mobile number within a prescribed period of 07 days, it shall be presumed that the candidate is not willing to opt for such appointment in the University.

The formal appointment order in favour of the selectees shall be issued separately only after receiving Character Antecedent from the concerned department in their favour.


