TERMS AND CONDITIONS

1. Offers will only be accepted from firms with a valid GSTIN, PAN, and an experience certificate for stall fabrication for exhibitions within the last two years.
2. The offers should be accompanied with copy of
 - Registration of firm issued by Competent Govt. body
 - GSTIN
 - PAN
3. The Stalls/Tentage should be ready by **18th November, 2024** before 12.00 noon.
4. The Exhibition Committee reserves the right to accept/reject the offer without assigning any reason thereof.
5. The payment shall be released to the firm only after satisfactory completion of the job contract on actual basis duly verified by the Committee constituted for the purpose.
6. The exhibition committee reserves the right to disallow any amount for not undertaking the job contract satisfactorily.
7. All disputes arising from this tender will fall under the jurisdiction of the courts of Jammu.
8. Quantity mentioned above are tentative and may increase or decrease.
9. Tenders shall be submitted in sealed main envelope containing two separate sealed envelopes subscribed as, "**Technical Bid**" and "**Financial Bid**" and the main envelop duly subscribed as "**Tender for Erection of stalls/ Tentage**".
10. If the same firm applies for both stall erection and tentage, the firm should include the "**Financial Bid for Tentage**" separately within the main envelope.
11. Demand draft towards tender processing charges, drawn in favour of Comptroller, SKUAST-J, Main Campus, Chatha, Jammu.
12. CDR/FDR amount as specified against each work be pledged in favour of "Comptroller, SKUAST- Jammu" towards Earnest Money Deposit.
13. Performance security @5% of the quoted amount in the shape of demand draft/FDR/ Bank guarantee from a nationalized bank shall have to be paid by the successful bidder and the same shall be released after satisfactory execution of the work.
14. The contractors/firms should not have been blacklisted/debarred from bidding/ tendering by any Govt., Semi Govt organization.
15. SKUAST---JAMMU shall not be liable for any damages or compensation at workmen law in respect of workmen or in consequence of any accident or injury to any workman or other person employed by the contractor except an accident or injury resulting from any action or default of the employer. The contractor should in all probability insure his workers engaged for the execution of the job.
16. In case of any controversy between the Supplier and the University, the decision of the Vice Chancellor of SKUAST-Jammu shall be final and binding on the tenderer. The last date for receipt of sealed offers by speed post/registered post subscribing "Tender for Erection of stalls/ Tentage" shall reach the office of Director Extension, SKUAST-Jammu, Main Campus Chatha, Jammu - 180009 by or before **6th Nov, 2024 up to 2:00 p.m.**
