The SGRC shall work with following terms and conditions as per University Grants Commission (Redressal of Grievances of Student) Regulations, 2023 notified by the University Grants Commission, New Delhi dated: 11.04.2023:

- i) The term of the chairperson and members shall be for a period of two years.
- ii) The term of the special invitee shall be one year.
- iii) The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.
- iv) In considering the grievances before it, the SGRC shall follow principles of natural justice.
- v) The SGRC shall send its report with recommendations, if any, to the Competent Authority of the institution concerned and a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint.
- vi) Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.


