

**Sub:- 2<sup>nd</sup> Final Selection list of candidates for the post of Cleaners advertised vide Notification No. 10 (Secy.) of 2023 dated 19.07.2023-regarding**

- WHEREAS, University, vide Notification No. 10 (Secy.) of 2023 dated 19.07.2023, advertised the 06 posts of Cleaners, with the category wise break up as under:

Post	OC	SC	ST	RBA
Cleaners	03	01	01	01

- WHEREAS, in terms of notified selection criteria, selection to the posts of Cleaners is required to be made on the basis of Written Test (85 marks) and additional weightage points awarded to the candidates on the basis of parameters viz. candidates whose no family member have been in government service, including in PSUs/Boards/Autonomous Bodies etc. (5 marks); and casual/season labourers/daily wagers and other contractual workers engaged through outsourcing of 5 years or more (5 marks).
- WHEREAS, SKUAST-Jammu conducted OMR based objective type written test examination of all the applicants of aforesaid positions on 28.12.2023.
- WHEREAS, on the basis of performance of the candidates in OMR based Objective Type Written Test Examinations conducted on 28.12.2023, coupled with the additional weightage points awarded to the candidates by the designated committee, the result of the candidates was declared vide no. AUJ/Secy./23-24/SLF-16/2297-99 dated 04.12.2023.
- WHEREAS, the declaration of the result was followed by the Documents Verification (DV) of the candidates falling under consideration zone in the ratio of 1:1, vide notification no. AUJ/Secy./23-24/SLF-16/2379-2381 dated 19.12.2023, by Documents Verification-cum-Selection committee constituted for the purpose.
- WHEREAS, on the recommendations of Documents Verification-cum-Selection committee, University appointed 02 candidates one under Open category and another under Scheduled Caste category vide University Order Nos. 224 (Secy.) of 2024 dated 01.07.2024 and 228 (Secy.) of 2024 dated 16.07.2024, respectively.
- WHEREAS, on the recommendations of Documents Verification-cum-Selection committee, the candidates falling next in consideration zone in the ratio of (1:3) on the basis of final score/merit of the candidates i.e. (Written Tests + additional weightage points) were called to appear physically before the designated Documents Verification Committee for verification/scrutiny of documents on 23.04.2025 and 30.04.2025 vide notification Nos. AUJ/Secy./25-26/SLF-16(5)/05-06 dated 02.04.2025 and AUJ/Secy./25-26/SLF-16/155-160 dated 23.04.2025 to fill up of the left over vacant positions of the Cleaners under various categories.
- WHEREAS, on the recommendations of Documents Verification-cum-Selection Committee, University notified the 2<sup>nd</sup> Provisional Selection List for the posts of Cleaner advertised vide notification No. 10 (Secy.) of 2023 dated 19.07.2023
- WHEREAS, the final selection list for the posts of Cleaner has been prepared after examining in detail all the relevant representations.
