As recommended by the Documents Verification-cum-Selection Committee and approved by the Hon'ble Vice Chancellor, sanction is hereby accorded to the temporary appointment of the following candidate, as Apprentice Technician (Farms/Laboratories)T1 in this University, as per details given hereunder:

The selection of Apprentice Technician (Farms/Laboratories)T1 shall be governed by following terms and conditions as per SKUAST Statutes in vogue and as shall come into force from time to time

- i) The aforestated Apprentice Technician (Farms/Lab)(T1) shall have to undergo apprenticeship at various Farms/Laboratories of the University for a period of two years. Provided that the candidates who have already undergone one Year's training in Agriculture /Horticulture /Animal Husbandry and Allied fields in a recognized institute or held B.Sc. Degree shall undergo apprenticeship for a period of one year only.
- ii) The Apprentice shall has to pass a test prescribed by the University in order to complete the apprenticeship satisfactorily.
- iii) The period of apprenticeship shall be extendable by six months in special cases where a candidate fails to complete the same satisfactorily subject to a maximum of one year. Candidate failing to complete the apprenticeship satisfactorily within the prescribed time limit shall forfeit her claim for appointment and apprenticeship shall stand terminated at the expiry of the stipulated period.
- iv) The Apprentice Technician (Farms/Lab)T1 shall receive stipend @ ₹3000/- per month during the apprenticeship period against Salary Head of account of the post against which the apprentice shall be adjusted.
- v) The Apprentice who is found guilty of misconduct or deliberate disobedience of orders or who repeatedly refuses to conform to the procedure prescribed for the conduct of training shall be terminated from the Apprenticeship forthwith.

- vi) That after successful completion of the apprenticeship, the rules in vogue shall be applicable to the appointment of the successful apprentice against the post of Technician (Farms/Lab)T1.
- vii) The above Apprentice Technician (Farms/Lab)T1 shall submit her joining report physically in the Office of Registrar, SKUAST-Jammu within a period of 21 days, failing which the selection of the candidate shall be cancelled ab-initio without any further notice.
- viii) The Selectee shall be allowed to join only on production of the following certificates in Original:
- Academic Qualification Certificates.*
 - Matriculation/ Date of Birth Certificate.*
 - Marksheet/ Degree Certificate of all qualifying examinations.*
 - the above apprentices are required to submit Medical Fitness Certificate issued by the Chief Medical Officer;*
 - Domicile Certificate issued by the Competent Authority.*
 - That if the candidate has taken any loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Center (DIC) and District Employment and Counseling Center of the domicile District, she shall relinquish the proprietorship of unit /enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the University Services. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.*
 - Relevant category certificate(s)*
 - Any other certificates/ documents as required under rules/ norms.*
- ix) The apprentice shall give an undertaking duly attested by the First Class Judicial Magistrate in the shape of an affidavit to the effect that:-
- if on verification from the concerned issuing authorities, the qualification certificate/reserved category certificate/experience certificate (wherever applicable) submitted by candidate is found forged, false or fake, her appointment shall be canceled ab-initio at the risk and responsibility of the concerned;*
 - The stipend of the apprentices shall not be drawn and disbursed to her unless and until the satisfactory report/ genuineness of the certificates in respect of condition (i) is received.*
 - The apprentices has no criminal records and also is not facing any criminal proceedings in any court of law.*
 - The apprentices shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in the selection order.*

The inter-se-seniority of the aforesaid apprentice shall be reckoned amongst the Technicians (Farms/Lab) T1 in the same order as mentioned in the select list notified vide No. 83 (Secy.) of 2024 dated 27.02.2024 on the basis of overall merit obtained by the candidates in the written test.

Consequent upon the above, Ms. Samiksha Sasan, Apprentice Technician (Farm/Lab)T1 is hereby adjusted against vacant post of Technician (Farm/Lab)T1 at AICRP Maize Research Centre, Udhampur for purpose of drawal of stipend during the apprentice period and attached in Division of Floriculture & Landscaping, Faculty of Basic Sciences, Chatha.

Further the aforesaid candidate after joining in the office of Registrar shall report to the Dean Faculty of Agriculture, Chatha for undergoing apprenticeship in various Farms/Laboratories of the University

The formal appointment order in favour of the aforesaid Apprenticeship Technician (Farm/Lab)T1 shall be issued separately after completion of the apprenticeship by the apprentice.


