Notification No. 15 (Secy.) of 2025
Dated 03.10.2025

- Whereas, based on the score obtained in the written test for the post of Audio-Visual-Operator, **S. Gagandeep Singh S/o S. Jasvir Singh**, R/o Village Indira Nagar, PO Miran Sahib, Tehsil R.S. Pura, District: Jammu – 181101, who fell under the consideration zone (1:1), was called for physical appearance before the Documents Verification-cum-Selection Committee on 24.05.2024 vide University Notification No. AUJ/Secy./23-24/SLF-16/826-27 dated 16.05.2024. He submitted the requisite documents along with an experience certificate of 2 years & 2 months (01.04.2019 to 31.05.2021) as *Audio-Video Equipment Technician* issued by *M/S Conscience Technical Training Centre (JK-125)*, Sarv Saksharta Abhiyan Trust (Govt. Regd.), Rampura, Shastri Nagar, Jammu.
- Whereas, the Committee withheld its recommendations in case of **S. Gagandeep Singh S/o S. Jasvir Singh** for want of 2 years experience from a Govt./Semi-Govt./University/Autonomous Bodies.
- Whereas, University vide letter No. AUJ/Secy./2024-25/F-SLF-16/1714 dated 11.06.2024, advised S. Gagandeep Singh to submit requisite 2 years experience certificate. Subsequently, a Final Notice was also served to him vide No. AUJ/Secy./2024-25/F-SLF-16/2579-81 dated 04.09.2024 by giving last/final opportunity to submit the requisite experience certificate.
- Whereas, S. Gagandeep Singh S/o S. Jasvir Singh thereafter submitted an experience certificate dated 03.08.2021 issued by Principal, Acharya Sri Chander Technical Institute (Polytechnic College), Ghou Manhasan, Jammu wherein it is stated that he had worked in this institute w.e.f. 01.08.2018 to 30.07.2021. To verify the authenticity, letters were sent to concerned institutions. The Principal, ASCTI, vide No. ASCTI/POLY/24/1352 dated 05.11.2024, authenticated the certificate and informed that the Institute is recognized by J&K Govt., DTE, affiliated to JKSBOTE and approved by AICTE. However, the letter sent to M/S Conscience Technical Training Centre was returned back undelivered.
- Whereas, the candidate on 19.12.2024 again submitted an experience certificate bearing No. CON/JK-125/24 dated 18.12.2024 from the *M/S Conscience Technical Training Centre (JK-125)*, this time certifying part-time evening-shift experience of 2 years & 2 months (01.04.2019 to 31.05.2021).
- Whereas, the Documents Verification-cum-Selection Committee observed that the experience certificates issued by Conscience Technical Training Centre (JK-125), Sarv Sakshatra Abhiyan Trust (Govt. Regd.), Rampura, Shastri Nagar, Jammu and Principal, Acharya Sri Chander Technical Institute Ascti (Polytechnic College), Ghou Manhasan Jammu overlap, creating ambiguity. Additionally, the experience certificate submitted by the candidate at the time of documents verification was later treated to be the experience from 01.04.2019 to 31.05.2021 on part time basis. Moreover, at the time of filling up of online application form for the post of Audio-Visual-Operator, S. Gagandeep Singh did

not mention the requisite 2 years experience as Audio-Video equipment technician or relevant trade from a Govt./Semi-Govt./University/Autonomous Bodies.


In view of the above facts, it is held that S. Gagandeep Singh S/o S. Jasvir Singh, R/o Village Indira Nagar, PO Miran Sahib, Tehsil R.S. Pura, District: Jammu – 181101 does not possess valid 2 years experience from a Govt./Semi-Govt./University/Autonomous Bodies, as prescribed in the Advertisement Notification No. 09 (Secy.) of 2023 dated 19.07.2023. Accordingly, he is declared *ineligible* for the post of Audio-Visual-Operator.
