All the desirous candidates seeking admission to UG programmes of SKUAST of Jammu, who have appeared in the SKUAST-J CET- (UG) 2025, and whose rank and merit category wise/overall rank-wise merit has been displayed and is available on the University website www.skuast.org are hereby informed that the Mop-up/Final round of counselling to UG programme is scheduled as per the details given below:

The candidates of the rank and score mentioned above, before attending the Mop-up/Final round of counselling must ensure that the following conditions are strictly adhered to, failing which the Admission cum Counselling Committee shall be within its rights not to consider any request, in case of deviation of these conditions:

- The candidates attending counselling shall have to produce the original documents as per information Brochure namely Date of birth certificate (Matriculation certificate), Marks certificate of qualifying examination (Marks Card of 10+2), Domicile certificate, Category certificate, if applicable (if belonging to any reserved category), along with self-attested photo copies of all the above documents, admit card of SKUAST-J CET (UG) 2025 and 04 Nos. of recent passport size coloured photographs.
- 2. The candidates before attending the counselling on the aforesaid date shall have to deposit counselling fee Rs. 1000/-(Non-refundable) through online mode, preferably one day before or on the counselling date up to 11:00 a.m. positively. For details in this regard log on www.skuast.org. The candidates having paid counselling fee of Rs. 1000/- in the previous rounds of counsellings shall not have to pay the counselling fee again.







- 3. If a candidate or his/her representative had failed to appear in previous counselling but intends to appear in Mop-up/Final round of counselling he/she will be allowed after depositing Rs. 1500/-(non-refundable) as counselling fee. Further, the candidate shall be considered for a seat in a course available at that point of time. Such candidates cannot stake any claim whatsoever on any other seat already allotted despite their merit. For further necessary details please visit. www.skuast.org
- 4. A candidate is required to attend the counselling on stipulated date/time, venue and present him/herself before the counselling committee when his/her name is announced, failing which the claim of admission on seats available at that point of time when he/she was called shall not be entertained in spite of superior merit. The allotment of seats for candidates who present themselves before counselling committee afterwards shall depend upon availability of seat(s) at the point of time, when he/she presents himself/herself before the Counselling Committee of SKUAST-J in the counselling hall only on stipulated dates of counselling.
- 5. The provisionally selected candidates shall preferably have to deposit requisite fee in full on the day of counselling, accordingly, the candidates are advised to come prepared for the same. - 6. The candidates provisionally selected / admitted under self-financing and NRI/NRIs sponsored/OCI category shall have to make an undertaking to the extent that he /she is in a position to pay the self-finance category fee/NRI/NRI sponsored/OCI for the whole duration of the degree programme and shall not request for any concession/exemption of fee at any time during the course of degree programme.
- 7. No Upgradation shall be permitted in mop-up round of counselling.
- For Self-Finance Category, in each degree programme, the selection of desirous candidates shall also be strictly based on merit obtained in the SKUAST-J CET (UG) 2025.
- The candidates are advised to visit University website www.skuast.org for other details and updated information.
- 10. The candidates invited for attending the counselling are more than the number of seats available. However, this is to accommodate the shortfall or vacancy arising, if any.
