Sub: Provisional Admission to M.Sc. Agriculture and Allied Sciences /M.Sc. Horticulture & Forestry after Mop Up round of counselling for the academic session 2025-26.

Consequent upon the recommendations of the Admission cum Counselling Committee the selected candidates as per the list (discipline wise) enclosed as **annexure-I** to this notification are granted provisional admission **M.Sc. Agriculture and Allied Sciences /M.Sc. Horticulture & Forestry** in the academic session 2025-26, subject to the condition that if at any point of time during the course of study programme, information furnished by a selectee/candidate is found incorrect or misrepresented or concealed or suppressed in any form, the admission granted would be cancelled forthwith and this University shall be at liberty to initiate the necessary action under rules against such selectee/candidate.

The selectee who has attended the counselling, but has not paid the prescribed fee as indicated against the name in the **annexure-I** to this notification, his /her selection shall be treated as cancelled.

The provisionally admitted / selected candidates are advised to report in the office of the Registrar on **06-11-2025** and **07-11-2025** during office hours along with the original certificates, two sets of self attested photocopies of testimonials and 5 Passport size photographs (in blue/red background) for filling up of the **admission form (which shall be downloaded from the University website: www.skuast.org)**. The candidates thereafter shall report to the concerned Dean of the Faculty/ Director, Institute of Biotechnology for registration in the 1st year, 1st semester of the academic session 2025.

The candidates who fail to report for admission in the University on the aforesaid dates, his/her admission shall be treated as cancelled.

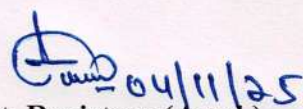
