## It is further notified that:

- 2. The Selection of the Candidate has been made on the basis of the Self declaration/Certificates submitted by the candidate and if at any stage, it comes to the light that candidate has submitted false information or has secured selection on the basis of fake documents/ certificates; her selection is liable to be cancelled in abinitio.

Further, in term of J&K Government Order No. 528-JK(GAD) of 2021 dated 21.06.2021 together read with circular no. 18-JK(GAD) of 2022 dated 20.05.2022, the selected candidate, has to submit her email address & mobile number in the Office of the Registrar, SKUAST-Jammu for registration under "Employee Verification System (EVS)" either in person or through email for verification of character and antecedents within a period of 15 days positively from the date of issuance of this order. In case, she fails to submit her email address & mobile number within a prescribed period of 15 days, it shall be presumed that she is not interested for such appointment in the University.

The formal appointment order in favour of the selectee shall be issued separately only after receiving verification report regarding Character and Antecedents from the concerned department in her favour.
