Sub: Provisional Admission to B.Sc. (Hons.) Horticulture Programme for the academic session 2025-26.

The provisionally admitted/selected candidates are advised to **report to the office of the Registrar on 03-12-2025** during office hours along with the original certificates, two sets of self attested photocopies of testimonials and 3 Passport size photographs for filling up of the **admission form** (which shall be downloaded from the University website.) **www.skuast.org**. The candidates thereafter shall report to the concerned Dean of the Faculty (along with a complete set of all the documents & 03 Nos. of Passport size photographs) for registration in the 1st year /1st semester of the academic session 2025-26.

The candidates who fail to report for admission in the University on the aforesaid dates his/her admission shall be treated as cancelled.
