2. a) The bids shall be deposited in electronic format on the website www.jktenders.gov.in from 13.07.2021 (9:30 A.M.) to 04.08.2021 (Upto 3:00 P.M.). The technical bids received will be opened on or after _____ online. Financial bids of only those bidders will be opened online who are found technically responsive by the evaluation committee/Standing Works Committee.
b) The complete bidding process will be online.
3. List of original copies of tender documents to be scanned and uploaded with the bid:-

 - iv. Demand draft for Rs.500/- towards the cost of tender documents, drawn in favour of Comptroller, SKUAST-J, Main Campus, Chatha, Jammu.
 - v. CDR/TDR for Rs.40,000/- towards the Earnest Money Deposit pledged in favour of Comptroller, SKUAST-J, Main Campus, Chatha, Jammu.
 - vi. Undertaking duly signed in the shape of affidavit that the Contractor/Firm has never been debarred or blacklisted by any Govt./Semi Govt. Boards and Corporations and all certificates enclosed by him are correct.
 - vii. The contractor has to upload his complete address, Mobile No. and email address alongwith the bid.
 - viii. **Hard copy of all the documents shall be deposited in the Office of the Prof and Head, Division of Agricultural Engineering, SKUAST-J, Main Campus, Chatha- Jammu-180009 (J&K U.T.) before submission of bid.**

Terms and Conditions:

- 1 The vehicles are to be auctioned through online bids on "As is where is basis" as per detail given above. The bidders can examine the vehicles at Parking Shed, SKUAST-J, Main Campus, Chatha, Jammu on any working day (Monday to Friday) between 09:30 AM to 05:00 PM.
- 2 Conditional bids shall be rejected out rightly.
- 3 The bids must be accompanied by earnest money amounting to Rs.. 40000/- (Forty thousand only) in the shape of CDR/TDR pledged to Comptroller, SKUAST of Jammu. The CDRs of unsuccessful bidders shall be released within one week after the finalization of auction. However, the CDR of successful bidders shall be released after depositing full amount of auction and completion of codal formalities.
- 4 100% amount of highest bid shall have to be deposited within two days of communication of the acceptance of the bid through Demand Draft favoring Comptroller, SKUAST-Jammu.
- 5 The bidders and their authorized representatives are at liberty to present themselves at the time of opening of the bids.
- 6 The Competent Authority of SKUAST-J does not bind itself/himself to accept the highest or any bid and reserves right of accepting/ rejecting the whole or any part of the bids without assigning any reason.
- 7 The bidders shall have to quote vehicles wise rates both in figures and words.
- 8 A bid containing mutilation, overwriting and corrections without due attestations by the bidder shall be liable to rejection.
- 9 All taxes/VAT, if any, shall be borne by the bidder.
- 10 The successful bidders shall have to lift the auctioned vehicles within two days of the issuance of the authorization letter at his own cost and after which SKUAST-J shall not be responsible for its watch and ward.
- 11 If the uploaded documents are found fake/fraudulent, Legal action as warranted under rules shall be taken against the defaulter.
- 12 The bid for the vehicles shall remain open for acceptance for a period of 90 days from the date of opening of technical bids. If any bidder/tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 13 The letters/notice etc. duly posted on the given address shall be considered as having been delivered to the contractor..
- 14 To participate in bidding process:-
 - i. The bidders have to get Digital Signature Certificate (DSC) as per Information Technology Act-2000 to participate in online bidding.
 - ii. The DSC will be required for digitally signing the bid. The bidders can get above mentioned digital certificate from any approved vendors. The bidders who already possess valid DSC need not to procure new DSC.
 - iii. The bidders have to submit their bids online in electronic format with DSC. The bids cannot be uploaded without Digital signature. No proposal will be accepted in physical form.
 - iv. Bids will be opened online as per time schedule mentioned above.
 - v. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
 - vi. The University will not be responsible for delay in online submission of bids whatsoever reasons may be.
 - vii. All the required information for bid must be filled and submitted online.
 - viii. The details of cost of documents, EMD specified in the tender documents should be the same, as submitted online (scanned copies) otherwise bid will not be accepted.
