Sub: Compassionate appointment of Sh. Nitish Sharma, S/o Late Sh. Pushap Kumar, Ex. OCC, SKUAST-Jammu under SRO-43 of 1994.

Ref : *Concurrence of Finance Department conveyed vide no. FA/Uni/SKUAST-J/SRO.43/2021/578 dated 03.03.2021, in light of Govt. Order No. 377-F of 2019 dated 04.07.2019 issued by the Finance Department, J&K Govt., Jammu.*

Sanction is hereby accorded to the temporary appointment of Sh. Nitish Sharma S/o Late Sh. Pushap Kumar, Ex. OCC, SKUAST-Jammu R/o H.No. 79, Ward No. 12, R.S. Pura, Jammu, as Orderly-cum-Chowkidar in the Pay level of SL 1 (14800-47100), under SRO-43 of 1994.

The appointee shall report to Estates Officer, Estates Division, SKUAST-J Chatha for further deployment to International Guest House, Chatha with in a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:

- i. All Academic qualification certificates
- ii. Matriculation/Date of Birth Certificate
- iii. Relevant category certificate, if any
- iv. Health Certificate issued by the Chief Medical Officer
- v. Domicile Certificate issued by the Competent Authority
- vi. Certificate from the concerned office (Deputy Director, Employment and General Manager, DIC) to the effect that no loan under self-employment scheme is pending against the selectee.
- vii. NOC from the employer, if employed

The appointment of the appointee, shall further be subject to the following conditions:

- (a) The appointee shall have to give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police, (CID), J&K to whom a reference shall be made by the University, the appointee shall have no right to claim his selection as Orderly-cum-Chowkidar, as such, shall be deemed to have his selection cancelled ab-initio.
- (b) If, on verification, genuineness of all the requisite documents from the concerned issuing authorities is found fake/forged, the claim of the appointee for appointment as Orderly-cum-Chowkidar, shall also be deemed to have cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- (c) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory reports in respect of (a) and (b) above are received in his favour.
