1. The application form along with a requisite application of fee of Rs. 60/- shall be submitted online along with all requisite documents. The form submitted without proper requisite documents shall be subjected to rejection.

2. Position is purely temporary basis and co-terminus with the project. Selected candidate will not be entitled for any claim for regular appointment/ absorption in SKUAST-Jammu or in sponsoring agency in future.
3. The project has been extended only for the financial year 2020-21. Hence, the person employed shall have no claim for continuation of the employment after the termination of the project. However, if the sponsoring agency extends the project for one or more financial year i.e. 2021-22 or onwards, the service of the person engaged on contractual basis is liable to be extended subjected to satisfactory performance and availability of the funds.
4. The candidate who will submit the application form within the specified time shall be informed for attending the provisional walk-in-interview offline/online as deemed fit.
5. Mere attending the interview shall not be treated as eligible for the post.
6. The appointment orders shall be issued to those candidates who will get their uploaded documents verified with the original one.
7. Candidates applying for more than one post shall submit separate application form along with required documents.
8. However, the decision of the concerned selection committee w.r.t eligibility shall be final and binding and no correspondence in this regard shall be entertained.
9. The effective date w.r.t. counting of age eligibility shall have the effect from 1st January of the advertisement year (i.e. 1st January, 2020).
